Stay straight to go onto Children's Drive where you will reach a dead end at Rockland Rd (the A.I. DuPont Children's Hospital is directly in front of you). Turn Right onto Rockland Rd, DuPont CC is approx. ¼ mile on the right.

From the South

I-95 N to Concord Pike/US 202 N via Exit 8 toward West Chester. Turn Left onto Powder Mill Rd/SR 141. Stay straight to go onto Children's Drive where you will reach a dead end at Rockland Rd (the A.I. DuPont Children's Hospital is directly in front of you).
